The Donor Relations Officer is responsible for carrying out the mission of the foundation by prospecting a diverse range of new individuals, families and corporations to become CFT fund holders and facilitating the cultivation and stewardship strategies for existing CFT fund holders. The Donor Relations Officer focuses on providing exceptional and differentiated service to prospective and existing donors, colleagues and other stakeholders.

Key Responsibilities

- Increase the foundation's assets through:
 - Creating and cultivating a prospect list of individuals, families and businesses, with a focus on racial and ethnic diversity;
 - Engagement efforts with existing fund holders that result in additional gifts to CFT funds;
 - Establishing CFT's role as a strategic and meaningful partner with individuals, businesses and foundations in minority communities;
 - Converting portfolio prospects and referrals to secure new gifts and funds; and
 - Serving as part of the Donor Relations & Services Team to share CFT services and solutions as a part of the foundation's development strategy.
- Manage outreach, strategy, engagement and stewardship of an active and diverse portfolio of CFT fund holders with a capacity for major gifts including six and seven figure donations, serving

as a proactive partner in enhancing and deepening their individual philanthropy and keeping them informed of CFT's programs and philanthropic partnership opportunities.

- Facilitate through philanthropic consulting customized short- and long-term solutions to meet fund holder needs, helping connect them to appropriate resources within CFT and the community.
- Handle complex donor, grant and fund issues through advanced research, communication, and documentation.
- Manage and steward CFT fiscal sponsorship funds.
- Collaborate with Marketing team to plan and oversee development and execution of donor-related publications, messaging, strategy and events related to job responsibilities.
- Additional responsibilities within the Relationships Department include:
 - Representing the Foundation publicly at events and meetings;
 - Support CFT's commitment to meeting the philanthropic needs of racially and ethnically diverse communities;
 - Serving on internal CFT committees;
 - Supporting North Texas Giving Day, as appropriate;
 - Other responsibilities as assigned.

- 5+ years successful experience in fundraising, stewardship or a related field, with positions of increasing responsibility and accountability in a goal-oriented setting
- Portfolio management experience and major gifts work a plus
- Knowledge of Raiser's Edge a plus
